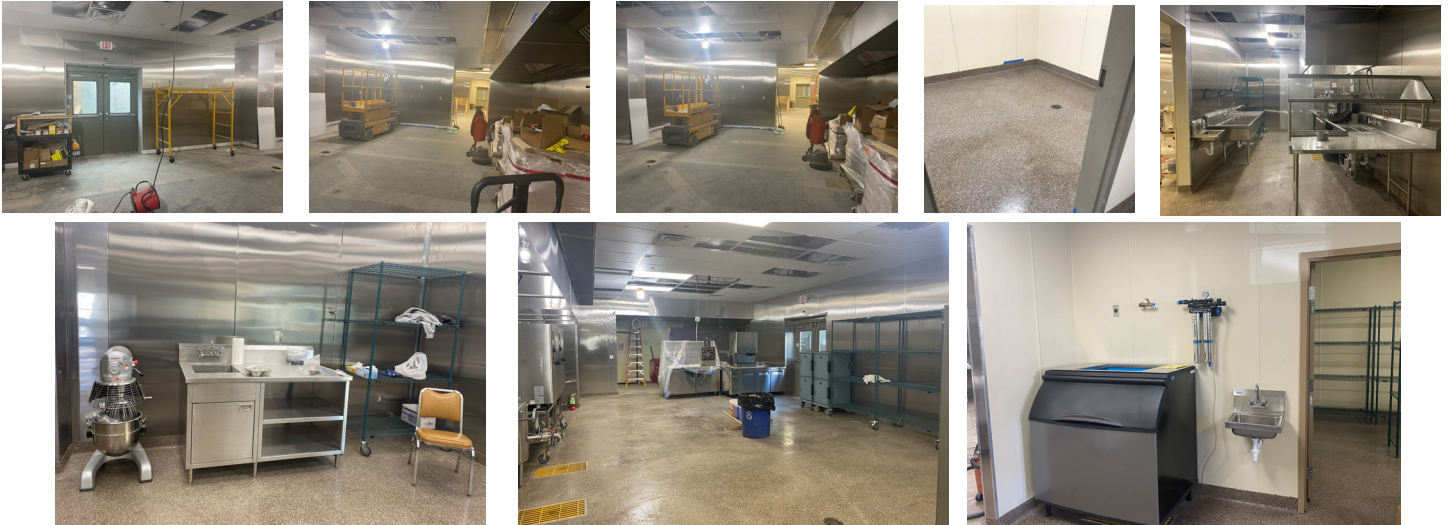
Christmas Hams!
